Attorney Admissions
(Rev. 12/13)

According to Local Rule Gen. 202(a) of this Court, in order to be eligible for membership in the Bar of this Court, an attorney must:

- (1) Be a member of good standing of the Bar of the Supreme Court of the State of Rhode Island; and
 - (2) **Either:**
 - (A) Have completed the course of instruction on Federal Practice and Procedure given by this Court's Board of Bar Admissions (See below for details about the Federal Bar Lectures), **or**
 - (B) Have at least five years of experience in practicing before federal courts and certify that he or she has read and understand these Local Rules (See below for details about being admitted without completing the course of instruction.);
- and
- (3) Establish to the satisfaction of this Court, that he or she is of good moral character and otherwise qualified and fit to be admitted to the Bar of this Court.

Application for Admission Pursuant to LR Gen 202(a)(2)(A)

An attorney who is a member in good standing of the bar of the Supreme Court of the State of Rhode Island may be admitted to the bar of this Court after taking the course of instruction on Federal Practice and Procedure (Federal Bar Lecture).

To be admitted under this rule, the attorney must file the following items with the Clerk of Court:

1. Application for Bar Admission. This form also serves as the registration form for the Federal Bar Lectures. (See instructions below for how to obtain this application.)
2. Certificate of Good Standing from the RI Supreme Court
3. Admission fee in the amount of \$231.00 payable to "Clerk, U.S. District Court"

Attendance at the Federal Bar Lectures is mandatory under this rule.

Federal Bar Lectures: Applications for the annual Federal Bar Lectures will automatically be mailed to attorneys who were sworn in to the bar of the Supreme Court of

the State of Rhode Island in the previous year. For example, attorneys sworn into the RI State Bar in 2013 will receive notification for the 2014 lectures. Any attorney who wishes to receive an application and does not believe that he or she is on the mailing list, should send a written request to the U.S. District Court, One Exchange Terrace, Providence, RI 02903 or contact the Clerk's Office by phone (401) 752-7200.

Applications are usually mailed to attorneys at the beginning of December, at which time the application and course materials will also be available to download from the Court's website at www.rid.uscourts.gov.

The Federal Bar Lectures are usually held during the 3rd and 4th weeks of January.

Application for Admission Pursuant to LR Gen 202(a)(2)(B)

An attorney who is a member in good standing of the bar of the Supreme Court of the State of Rhode Island **and** is a member in good standing of the bar of any other United States District Court may be admitted to the bar of this Court without taking the course of instruction on Federal Practice and Procedure, provided the person can

- a.) establish to the satisfaction of this Court that he has at least five (5) years of experience in practicing before federal courts; and
- b.) certify that he or she has read and understands the Local Rules of this Court.

If the applicant meets the above requirements, the following items shall be filed with the Clerk of Court:

1. Application for Admission to the Bar Pursuant to LR Gen. 202(a)(2)(B). This application can be obtained from the Court's website at www.rid.uscourts.gov. The applicant may attach supplemental information to the form as to his experience in practice before the federal courts;
2. A current Certificate of Good Standing from the Supreme Court of the State of Rhode Island; and
3. A current Certificate of Good Standing from one of U.S. District Court where the applicant is a member.
4. Admission fee in the amount of \$231.00 payable to "Clerk, U.S. District Court"
