Dear Judge Lisi:

As a follow-up to Your Honor's request at the Open Session Conference held in the above-referenced action on September 12, 2013, we wanted to provide the Court with an update as to the approximately 60 plaintiffs with cases pending in the MDL from whom - as of the time of the Open Session Conference - we had not received a settlement package and/or have not entered into settlement discussions.

Before and after the Open Session Conference, we mailed out letters to various plaintiff's counsel and pro se plaintiffs. We obtained the e-mail and physical addresses from the complaint and/or from the docket sheet. Where e-mail addresses were not found on the docket sheet, we searched the Internet, including law firm websites and bar association websites, for potential e-mail addresses.

After a review of the addresses by Plaintiffs' Liaison Counsel, who did not have any further information with regard to contact information for the recipients, we mailed plaintiff's counsel and pro se plaintiffs either the first or second attached template letter along with the third attached template letter that: (i) requested a settlement package if we had not previously contacted plaintiff's counsel or the pro se plaintiff (see Exhibit 1); (ii) followed up on prior correspondence requesting a settlement package (see Exhibit 2); plus (iii) notified the recipient that we would be providing the Court with a list of those plaintiffs we had not heard from regarding the settlement program pursuant to the Court's instructions during the Open Session Conference (see Exhibit 3).

As of the date of this letter, we are pleased to report that we have received settlement packages for 29 plaintiffs. We have also communicated with another 17 plaintiffs relating to the timing for the receipt of

settlement packages. However, and as indicated in the attached chart (see Exhibit 4), for 15 plaintiffs, plaintiffs' counsel and/or the pro se plaintiffs have not contacted us since the mailing of the letters.
