### Driving directions to the Convention Center Parking Garage

#### From North: (I-95 South)

- Take I-95 South to Exit 22, towards Downtown/Hartford CT.
- Keep left at the fork on the ramp to Exit 22A.
- Merge onto Memorial Blvd.
- At light continue straight on Memorial Blvd.
- At next light take right onto Exchange Street.
- Proceed to the stop sign. At the stop sign, turn right onto Exchange Terrace.
- Go straight through the traffic light and bear right onto West Exchange Street to end of tunnel.
- Turn right to park in the North, or left to park in the South Convention Center Parking Garage.

## From South: (I-95 North)

- Take I-95 North to Exit 22, towards Downtown/Hartford CT.
- Keep right at fork on the ramp to Exit 22A.
- Merge onto Memorial Blvd.
- At light continue straight on Memorial Blvd.
- At next light take right onto Exchange Street.
- Proceed to the stop sign. At the stop sign, turn right onto Exchange Terrace.
- Go straight through the traffic light and bear right onto West Exchange Street to end of tunnel.
- Turn right to park in the North, or left to park in the South Convention Center Parking Garage.

## From East: (I-195 West)

- Take I-195 West.
  - Merge onto I-95 North/US-6 West.
  - Take Exit 22, towards Downtown/Hartford CT.
  - Keep right at fork on the ramp to Exit 22A.
  - Merge onto Memorial Blvd.
  - At light continue straight on Memorial Blvd.
  - At next light take right onto Exchange Street.
  - Proceed to the stop sign. At the stop sign, turn right onto Exchange Terrace.
  - Go straight through the traffic light and bear right onto West Exchange Street to end of tunnel.
  - Turn right to park in the North, or left to park in the South Convention Center Parking Garage.

#### From West: (Route 6 or Route 44)

- Route 6 East or Route 44 East to 295 South.
- Take Exit 6 follow signs to Route 6 East Providence.
- Stay on Route 6 East until it merges left onto the Route 6/10 connector.
- Take the Exit for Downtown Providence.
- Merge onto Memorial Blvd.
- At light continue straight on Memorial Blvd.
- At next light take right onto Exchange Street.
- Proceed to the stop sign. At the stop sign, turn right onto Exchange Terrace.
- Go straight through the traffic light and bear right onto West Exchange Street to end of tunnel.
- Turn right to park in the North, or left to park in the South Convention Center Parking Garage.
