### FEDERAL COURT/BAR ACCESS TO JUSTICE INITIATIVE

The United States District Court for the District of Rhode Island is pleased to announce the launch of its Federal Court/Bar Access to Justice Initiative (“Initiative”), which for the first time formally welcomes law firms as members of the Court’s Pro Bono Panel.

The Initiative is designed to strengthen and expand legal support for self-represented civil litigants. Through this Initiative, the Court partners with both individual attorneys and participating law firms to provide high-quality pro bono representation to those who would otherwise navigate the federal court system alone.

By integrating law firms into the Court’s Pro Bono Panel for the first time, the Initiative enhances the scope of available resources and reinforces the legal community’s shared commitment to ensuring fair and meaningful access to justice. The Court is grateful to the dedicated attorneys and firms who volunteer their time, expertise, and advocacy in support of this important mission.

Until now, the Panel has been composed solely of individual attorneys.
