**NOTICE OF FILING OF CORRECTED JOINT STIPULATION AND [PROPOSED]
ORDER EXTENDING CERTAIN CASE SCHEDULE DEADLINES RELATED TO
FACT DISCOVERY AND BRIEFING ON CLASS CERTIFICATION AND
SUMMARY JUDGMENT ON ISSUES OF RELEVANT MARKET**

The direct purchaser class plaintiffs hereby give notice of the filing of a Corrected Joint Stipulation and [Proposed] Order Extending Certain Case Schedule Deadlines Related to Fact Discovery and Briefing on Class Certification and Summary Judgment on Issues of Relevant Market (“Corrected Stipulation”). The Corrected Stipulation is attached hereto as Exhibit 1.

The Corrected Stipulation differs from the originally filed stipulation (ECF No. 371) only with respect to (1) the language of footnote 1 (page 1), and (2) the deletion of a sentence in the third paragraph (page 2). Counsel for the direct purchasers inadvertently filed an incorrect version of the stipulation on June 11, 2018 that differed from the final joint stipulation agreed to by each party. The proposed order filed with the original stipulation (ECF No. 371-1) was correct as filed and has not changed.
