Notes 1 and 2 on the floor plan/layout depict wall and door locations related to this quotation. All mechanical, electrical, lighting, HVAC, and construction work will be performed by the government prior to the installation of the new wall system. The successful bidder will be required to take final measurements and make any necessary modifications to the dimensional specifications once the construction is complete and prior to the installation of the wall system.

SPECIAL NOTES/INSTRUCTIONS:

This is a request for **Open Market Pricing**.

All items should be quoted **F.O.B. Destination** to the Bidder/Dealer's shipping facility.

A fixed price award from this RFQ will be made based on the lowest priced, technically acceptable offer.

The **installation address** for this purchase will be: <u>One Exchange Terrace</u>, <u>Providence</u>, <u>RI</u> <u>02903</u>. The walls will be installed on the 4th floor of the building. There is no freight elevator. Walk-up delivery for some wall components may be required.

The U.S. District Court for the District of Rhode Island is exempt from all state sales tax. Do not include any sales tax in the proposal figure. The successful bidder will be furnished with the Court's tax exemption certificate upon request.

The total price quoted by the Bidder must be the total installed price and should include all costs associated with the purchase of the product in its entirety, any/all freight costs, design, and any/all installation and labor fees.

Due to the COVID-19 Pandemic, appointments are required for site visits/walkthrough. The Scope of Work included in this RFQ is as follows:

- 1. Supply new, semi-permanent modular walls to create two (2) individual, office areas. Total wall material measures approximately 29 linear feet.
 - a. Walls
 - i. Shall be approximately 90" high. Bottom 3rd shall be wood veneer panel, top should clear, tempered glass transom.
 - ii. The outside face of the wall shall have
 - 1. Aluminum frames
 - 2. MDF or equal/similar lower panel with a wood veneer finish
 - iii. The interior face of the wall shall have
 - 1. Aluminum frames
 - 2. Acoustical fabric/tack board panel (Fabric selection TBD)
 - b. Doors:
 - i. Sliding Barn Style
 - ii. Wood veneer
 - iii. Frosted center pane approximately 10" wide and of an appropriate length for the height of the door
 - iv. Soft close
 - v. 30" pull bars (style and color TBD)
 - vi. Hardware lock core should be removable so that it can be keyed to the appropriate building system. Color of door and hardware TBD.
- 2. Include all associated floor tracks, pieces, supports, tubes, connectors, corners, end caps, and the like. Walls will **not** go to the ceiling.
- 3. Include any/all freight expenses as a separate line item.
- 4. Include any/all labor to deliver and install the wall system as a separate line item.
- 5. Include any associated design/planning fees on a separate line (if applicable).
